We commit ourselves to making full payment of school fees as detailed in Section C of the
school enrolment application form, regularly and promptly and in line with the conditions of
enrolment.
We agree to give one school term's notice in writing of our intention to withdraw our child
from Jireh Christian School. We understand that failure to give this notice will incur a Term
Notice Fee.
We accept that our child's continued attendance at Jireh Christian School is subject to us
fulfilling the commitment we have made. We, therefore, sign with the full intention of meeting
these obligations and responsibilities.
