Conditions of Enrolment

We accept as conditions of enrolment that:

We will notify the school of any change in the information contained in the Application Form as
soon as is reasonably possible.
We will ensure that the policies and rules as laid down by the Board of Trustees and School
Management are observed.
We accept responsibility for the payment of school attendance dues and special
character donation by direct debit one term in advance (payments made on the $1\ensuremath{^{\text{st}}}$ of
January, April, July and October).
We acknowledge that we will inform the school a term in advance if we wish to withdraw our
child(ren).
Within two weeks of notification of acceptance to Jireh Christian School we will pay one term's
costs of \$650.00 to secure a placement.
Where school costs remain uppeid and no alternate arrangement has been made between the
