- Visit and assess the home of the caregiver, to ensure that living conditions meet with the Education (Pastoral Care of International Students) Code of Practice 2016 ('the Code') guidelines.
- Determine that the accommodation is not a boarding establishment, (i.e. does not have 5 or more international students staying in the home).
- Require a New Zealand Police vet to be undertaken by all members of the household aged 18 years of age and above.

Should circumstances change, I/We undertake to inform Jireh Christian School immediately.

I/We understand that Jireh Christian School will:

- ensure that international students study in a safe environment;
- provide adequate support for the well-being of their international students;
- as far as practicable ensure that international students live in a safe environment.
(Ref the Code Outcome 6: clause 21 p.10)

The intent of this outcome is to ensure students are as well supported as possible to have a safe, happy and successful time living and studying in New Zealand.

Should a concern regarding the welfare of the student arise, the school will consult with its pastoral care staff. I/We understand that Jireh Christian School may immediately rehouse the student to another approved homestay, if it deems it necessary to do so. Furthermore, Jireh Christian School may refer matters to Oranga Tamariki, the New Zealand Police or other appropriate Government agencies.
