

International Student Parental Agreement Re: Appointed Residential Caregiver

- I/We understand that all Jireh Christian School Residential Caregivers are assessed in accordance with the standards of the Education (Pastoral Care of International Students) Code of Practice 2016 (the'Code'). The Code can be viewed at: <u>http://www.legislation.govt.nz/regulation/public/2016/0057/latest/DLM6748147.html?src=qs</u>
- 2. I/We understand that my/our child is required to be on his/her best behaviour at all times. I/We further understand that if my/our child displays a prolonged and unacceptable level of behaviour, this may lead to the termination of my/our child's enrolment at Jireh Christian School.
- 3. I/We understand that my/our child may not make national or international telephone calls from the Residential Caregiver's home, unless it is with the Residential Caregiver's consent. If any such calls are made, I/we guarantee to reimburse the Residential Caregiver for any costs.
- 4. I/We understand and agree that my/our child will remain in the care of the Residential Caregiver that Jireh Christian School has appointed them to. However, if it is deemed necessary that a change of accommodation is required, then it remains the responsibility of Jireh Christian School to rehouse my/our child to another approved Residential Caregiver. Notice will be given by the school in writing.
- 5. I/We understand that Jireh Christian School will relay personal information that relates to my/our child's safety and well-being to the Residential Caregiver.
- 6. I/We understand that the Residential Caregiver will immediately communicate information about my/our child's safety and well-being to Jireh Christian School.
- 7. My/our child will not:
 - a. Stay away from the home of the Residential Caregiver overnight unless the consent of the Residential Caregiver, the International Group Coordinator and Jireh Christian School's International Coordinators is given.
 - b. Be left unsupervised. New Zealand law states, 'All children under the age of 14 years old are to be supervised by an adult at all times.'

8. I/We understand that this agreement shall be construed and take effect in accordance with the domestic laws of New Zealand. In relation to any legal action or proceedings arising out of or in connection with this agreement the parents/legal guardians irrevocably submit to the jurisdiction of the courts of New Zealand, agree that proceedings may be brought before any court including any forum constituted under the Arbitration Act 1908 within New Zealand and waives any objection to proceedings in any such court, or forum, on the grounds of venue or on the grounds that the proceedings have been brought in an inconvenient forum.
